### DECLARATION OF COVENANTS AND RESTRICTIONS

## DOVE'S REST

SUPERIOR SAND, INC., a Florida corporation, hereinafter called declarant, is the owner in fee simple of certain real property located in Polk County, Florida, more particularly described as:

## TRACT I:

The S 1/2 of the NE 1/4 of the SE 1/4 of Section 1, Township 29 South, Range 26 East, LESS AND EXCEPT Dove's Rest, as shown by map or plat thereof recorded in the office of the Clerk of the Circuit Court in and for Polk County, Florida, in Plat Book 73, Page 36.

### TRACT II:

All of Dove's Rest, as shown by map or plat thereof recorded in the office of the Clerk of the Circuit Court in and for Polk County, Florida, in Plat Book 73, Page 36.

For the purpose of developing and operating an attractive Recreational Vehicle/Mobile Home Park, the declarant hereby declares that all of the real property described above and each part thereof shall be held, sold and conveyed only subject to the following covenants and restrictions, which shall constitute covenants running with the land and shall be binding on all parties having any right, title, or interest in the above-described property or any part thereof, their heirs, successors, and assigns, and shall inure to the benefit of each owner thereof.

- 1. Definitions: The terms used in this Covenants and Restrictions shall have the following meanings:
- a. Association means the Dove's Rest Lot owners Association and its successors.
- b. Common Elements shall include the real and tangible personal property required for the maintenance and operation of the park and the recreation facilities including roadways, club house, swimming pool, laundry facilities, etc.
- c. Common expenses include expenses of administration expenses of insurance, maintenance, operation, taxes, repair, replacement and betterment of the common elements; the cost of providing water and sewer service for each lot as well as the common elements.
- d. Regulations means the rules and regulations respecting the use of the use of the common elements that are adopted by the Association from time to time.
  - 2. The owner of each lot shall own a share and certain interests in the common element, which share and interests are appurtenant to his lot, including but not limited to the following items:
  - a. An undivided 1/130th interest in the common elements when conveyed in accordance with paragraph 6 below.
  - b. Use of the common elements in with otherlot owners as provided for by the regulations.
  - c. Membership of each lot owner in the Association and 1/130th interest in the funds and asset held by the Association.
    - 3. Each lot owner shall be liable for an equal share of the common expenses. It is

understood that as of the date of the recording of this instrument that the monthly common expense is Forty Five Dollars (\$45.00) which may be adjusted by the Association no more frequently than annually.

- 7. The declarant, its successors or assigns, reserves for itself the right at any time to enter upon the private lots to maintain, install or repair utilities.
  - 8. No business or profession of any kind shall be conducted on the property.
- 9. Lot owners shall not permit any noxious or offensive activity or public or private nuisances to be conducted in or on their property.
- 10. No animals, livestock, or poultry of any kind shall be raised, bred, or kept on the property: provided, however, than dogs, cats, or similar household pets may be kept on the property as provided in the Rules and Regulations. Pet owners must comply with the Polk County Leash Ordinance.
- 11. No fence, hedge wall or other dividing instrumentality shall be constructed within the front one-half of any private lot. No fence, hedge, wall, or other dividing instrumentality shall be constructed or maintained within the rear one-half of any private lot that has a height in excess of three (3) feet.
- 12. No TV satellite microwave dish shall be used on the property. No television or other type of antenna may be permitted in excess of twenty five (25) feet in height from the ground.
- 13. Each lot owner shall be required to maintain bis property in a clean and sightly condition, including the proper trimming, and pruning of grass, weeds, trees, or other underbrush.
- 14. All structures or improvements must conform to the Planned Unit Development PUD 81-2 as modified zoning classification of the property.
  - 15. The Rules, Regulation and Restrictions of DOVE'S REST referred to herein shall

# DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS (CCRs) WINTER HAVEN CHRISTIAN CENTER, INC., D/B/A DOVE'S REST

Winter Haven Christian Center, Inc., d/b/a Dove's Rest, a Florida corporation, hereinafter sometimes referred to as declarant, is the corporation which governs certain real property located in Polk County, Florida, more particularly described as:

#### Tract I:

The S ½ of the NE ¼ of these ¼ of Section 1, Township 29 South, Range 26 East, less and except Dove's Rest, as shown by map or plat thereof recorded in the office of the Clerk of the Circuit Court in and for Polk County, Florida, in plat book 73, page 36.

#### Tract II:

All of Dove's Rest, as shown by map or plat thereof recorded in the office of the Clerk of the Circuit Court in and for Polk County, Florida, in plat book 73, page 36.

Dove's Rest Addition, recreation vehicle and mobile home subdivision Polk County, Florida

Section I, Township 29 South, Range 26 East

This corporation shall, consistent with such purpose be authorized to erect, construct, purchase, repair, improve, maintain, and operate recreational and residential properties within any facility owned by it which shall be exclusively for the benefit of its member-stockholders, and to otherwise promote social intercourse among them. The declarant hereby declare that all of the real property described above and each part thereof shall be held, sold and conveyed only subject to the following CCRs, which shall constitute covenants running with the land and shall be binding on all parties having any right, title, or interest in the above-described property or any part thereof, their heirs, successors, and assigns, and shall insure to the benefit of each owner thereof.

- 1. Definitions: the terms used in these CCRs shall have the following meanings:
  - a. Corporation means those persons owning property and stock certificates within Winter Haven Christian Center, Inc., dba Dove's Rest and the Board of Directors that manages said corporation.
  - b. Subdivision herein is defined as Winter Haven Christian Center, Inc., d/b/a Dove's Rest.
  - c. Governing documents mean the CCRs as created by stockholders of Winter Haven Christian Center, Inc., d/b/a Dove's Rest. These CCRs conform to Florida Statutes Chapter 719 Cooperative Act as it may be amended from time to time.
  - d. Stockholder or unit owner means Winter Haven Christian Center, Inc., dba Dove's Rest lot owners and their successors.
  - e. Common areas shall include but not be limited to the real and tangible personal property required for the maintenance and operations of the subdivision and the recreation facilities including, but not limited to, roadways, water and sanitary sewer systems, clubhouse, swimming pool, garages, office, shuffleboard court, pickleball court, pavilion, etc.
  - f. Common expenses include administration, insurance, maintenance, operation, taxes, repair, replacement and betterment of the common areas, the cost of providing water and sewer service infrastructure to each lot as well as the common areas.
  - g. By-laws and Rules mean the rules and regulations respecting the use of the common areas and private lots that are adopted by this corporation from time to time.
- 2. The owner of each lot shall own a share and certain interests in the common areas, which

share and interests are appurtenant to their lot, including but not limited to the following items:

- a. An undivided 1/129th interest in the common areas when conveyed in accordance with paragraph 6 below.
- b. Use of the common areas in common with other lot owners as provided for by the Bylaws and Rules.
- c. Membership of each lot owner in the corporation and 1/129th interest in the funds and assets held by the corporation.
- 3. Each unit owner shall be liable for an equal share of the common expenses which may be adjusted by the Board of Directors no more frequently than annually.
- 4. Winter Haven Christian Center, Inc., d/b/a Dove's Rest shall be formed to provide for the maintenance and operation of the common areas. The corporation shall adopt By-laws and Rules to govern the use of the common areas and private lots.
- 5. These CCRs supersede the provisions of the master form ninety-nine-year lease previously recorded in the public records of Polk County, Florida, in Official Records Book 2282, at Pages 0230 thru 0233, inclusive.
- 6. The declarant, its successors or assigns, shall convey title to the common areas to the corporation at such time as the declarant, its successors or assigns, holds title to the same free and clear of all encumbrances.
- 7. The declarant, its successors or assigns, reserves for itself the right at any time to enter upon the private lots to maintain, install, inspect, or repair utilities.
- 8. No home or any lot shall be used for any commercial or business purpose so that it causes clients, customers, or other non-residents to enter Dove's Rest subdivision for such commercial and business purposes.
- 9. Lot owners shall not permit any noxious or offensive activity or public or private nuisances to be conducted in or on their property.
- 10. No animals, livestock, or poultry of any kind shall be raised, bred, or kept on the property; provided, however, that dogs, cats, or similar household pets may be kept on the property as provided in the Subdivision Rules.
- 11. Each stockholder shall be required to maintain their property in accordance with the Rules and in a clean and sightly condition, including the proper trimming, and pruning of grass, weeds, trees, or other underbrush.
- 12. All structures or improvements must conform to the Planned Unit Development PUD 81-2 as modified zoning classification of the property.
- 13. The By-Laws, Rules and CCR's of Dove's Rest referred to herein, as may be amended from time to time, shall be considered as Covenants running with the land, and shall bind the owners of all lots, their heirs, personal representatives, successors and assigns, and if said owners, their heirs, personal representatives, successors or assigns shall violate or attempt to violate any of these ByLaws, Rules and CCR's, it shall be lawful for the declarant, the Corporation, or any person or persons owning any lots in Dove's Rest to prosecute any proceeding at law or in equity against the person or persons violating or attempting to violate any such By-Laws, Rules or CCR's, and either to prevent him or them from doing so or to recover damages for such violation including costs of the suit and a reasonable attorney's fee. Any invalidation of any of the afore described By-laws, Rules and CCR's shall in no way affect any other of the provisions thereof which shall thereafter remain in

- full force and effect. The governing documents referred to in this paragraph are available at the corporate office of the corporation.
- 14. The declarant, its successors or assigns shall provide water and sewer facilities to the owner's property in the adjacent applicable easements. Stockholders are responsible for the cost and installation of water and sewer infrastructure on their property and usage expense of potable water as recorded on stockholder-owned water meters. Stockholder/residents who reside temporarily in recreational vehicles (RVs) must connect the disposal system and water lines of their vehicles to the provided facilities. The stockholders are responsible for the maintenance and repair of any above ground or below ground utility on their property/premises.

The foregoing CCRs have been approved by not less than two-thirds of the units in accordance with the provisions of §719.1055, Florida Statutes.

(These CCR's of Winter Haven Christian Center, Inc. were amended by the stockholders on March 7, 2022 at the Annual Meeting. The amendments were passed with an affirmative vote of 2/3 of all 129 stockholders, voting present, absentee or by proxy. There were 110 affirmative votes, 12 no votes and 7 stockholders not submitting a vote. The amendments passed.)
